- Work in collaboration with Guyahyn playgroup and Jarjum Centre Preschool in the design of culturally immersed playgroup session plans for supported playgroup, and in home delivery across the LGA's of Lismore, Casino, Ballina, Kyogle, Tweed Heads, Byron Bay, Murwillumbah NSW.
- Promote and support formalised early childhood education learning for parents and caregivers
- Work closely with key partner services and community networks maintaining positive interagency relationships.
